

## **BLAST - FNCS - TERMS & CONDITIONS**

1. Those aged 16 and above are welcome to purchase tickets. Individuals under 16 must either be accompanied by an adult or provide signed parental consent. Everyone attending the event needs a ticket. Valid photo ID may be required for entry.
2. Elements of the show could potentially trigger seizures for people with photosensitive epilepsy. Attendee discretion is advised.
